#### **Dear Shareholders**

It has been great honor and privilege for me to take you through our performance strides of the financial year 2020-2021. As you know, the havoc of "Covid'19" pandemic outbreak has been crippled normal life and commercial activities in big way across the globe for two years now. It is needless to tell you that the impact of the pandemic on social life and commercial activities has been quite intense. Almost all business verticals except pharma and IT have been under immense pressure for survival in this critical period and we are not an exception to the common global phenomenon. Surprisingly, no one in the market is talking about growth prospects now a days rather all are working hard to evolve strategies for existence and survival, which is quite unique instance, I suppose.

Of course, all business verticals have both common and domain-specific challenges in this kind of critical phase. In our line of business, liquidity management remains the major challenge. In order to bring control over pandemic outbreaks, Governments at centre and state level have been imposing lockdowns and travel controls quite off and on during the last two years. Obviously, lockdown and travel restrictions have huge impact on our collection performance. It will not only restrict our field follow-up with defaulters but also their financial stability, especially, of marginal segment of clients. Naturally, it results into decline of fund inflow into the system by the way of collection and recovery. Meanwhile, institutional funders also stopped debt funding, for time being, considering the high risk that involved in funding in a volatile market, which has further intensified our crisis. In such a situation treasury management has become a nightmare for us as any other company of our size and scale.

The phrase that 'necessity is the mother of invention' has been proved true in our case. We did not succumb to the situational pressure rather decided to fight it out. We shifted our focus from institutional debt to retail debt and continued our collection follow-up even during the lockdown and travel restrictions were imposed. We have succeeded in convincing most of our clients to pay up dues even during the stress time without opting for the moratorium. Similarly, debt mobilisation through debentures under private placement also picked up well. As a result, we could overcome

the liquidity crunch and honour all our financial obligations including loan repayments without default of even a single day. You will be happy to know that our alternative retail debt mobilisation channel which we initiated during the crisis period has been growing strength to strength and it supplements our debt requirement to a great extent nowadays.

Unfortunately, we could not do much on top-line performance during this financial year, too. As a result, our portfolio has been declined substantially in year 2020-2021. In spite of all these hurdles, we have been able to manage our bottom-line performance quite well. Though there is a slight decline in our revenue during the year 2020-2021, our profit has been quite consistent. The austerity measures that have been implemented during the pandemic period has helped us to improve our bottom-line performance, which is indeed a remarkable achievement. I take this opportunity to express my sincere gratitude to all our team members for extending support and co-operation for implementing the austerity measures at the time of crisis.

It is true that we have been managing subsequent waves of the pandemic with more confidence and determination and are more equipped now to handle any such crisis in future, too. It seems that normalcy is not a distant reality now and once it is back, we will bounce back and move on with aggressive growth strategies. I'm fully confident that we will continue with our institution-making process with much more determination and dedication in the days to come.

The current market trends and indications are quite positive about the future. Pandemic will not stay for long and it will move away from the mind of people over a period and normalcy will return in social life and commercial activities soon. Of course, vaccination will do a significant role in restoring normalcy in life and activities across the globe.

Let us hope for the best!

## CDSL E-VOTING SYSTEM – FOR E-VOTING AND JOINING VIRTUAL MEETINGS

- As you are aware, in view of the situation arising due to COVID-19 global pandemic, the general meetings of the companies shall be conducted as per the guidelines issued by the Ministry of Corporate Affairs (MCA) vide Circular No. 14/2020 dated April 8, 2020, Circular No.17/2020 dated April 13, 2020 and Circular No. 20/2020 dated May 05, 2020. The forthcoming AGM/EGM will thus be held through video conferencing (VC) or other audio visual means (OAVM). Hence, Members can attend and participate in the ensuing AGM/EGM through VC/OAVM.
- 2. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and MCA Circulars dated April 08, 2020, April 13, 2020 and May 05, 2020 the Company is providing facility of remote e-voting to its Members in respect of the business to be transacted at the AGM/EGM. For this purpose, the Company has entered into an agreement with Central Depository Services (India) Limited (CDSL) for facilitating voting through electronic means, as the authorized e-Voting's agency. The facility of casting votes by a member using remote e-voting as well as the e-voting system on the date of the EGM/ AGM will be provided by CDSL.
- 3. The Members can join the EGM/AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the EGM/AGM through VC/OAVM will be made available to atleast 1000 members on first come first served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the

- EGM/AGM without restriction on account of first come first served basis.
- The attendance of the Members attending the AGM/EGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013.
- 5. Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, , the facility to appoint proxy to attend and cast vote for the members is not available for this AGM/EGM. However, in pursuance of Section 112 and Section 113 of the Companies Act, 2013, representatives of the members such as the President of India or the Governor of a State or body corporate can attend the AGM/EGM through VC/OAVM and cast their votes through e-voting.
- 6. In line with the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated April 13, 2020, the Notice calling the AGM/EGM has been uploaded on the website of the Company at www.tattvafincorp.com. The AGM/EGM Notice is also disseminated on the website of CDSL (agency for providing the Remote e-Voting facility and e-voting system during the AGM/EGM) i.e. www.evotingindia. com.
- The AGM/EGM has been convened through VC/OAVM in compliance with applicable provisions of the Companies Act, 2013 read with MCA Circular No. 14/2020 dated April 8, 2020 and MCA Circular No. 17/2020 dated April 13, 2020 and MCA Circular No. 20/2020 dated May 05, 2020.
- 8. In continuation of this Ministry's General Circular No. 20/2020, dated 05th May, 2020 and after due examination, it has been decided to allow companies whose AGMs were due to be held in the year 2020, or become due in the year 2021, to conduct their AGMs on or before 31.12.2021, in accordance with the requirements provided in paragraphs 3 and 4 of the General Circular No. 20/2020 as per MCA circular no. 02/2021 dated January,13,2021.



## THE INTRUCTIONS OF SHAREHOLDERS FOR E-VOTING AND JOINING VIRTUAL MEETINGS ARE AS UNDER:

- 1. The voting period begins onTuesday, the 9th November, 2021 at 9.00 am and ends on thursday, the 11th November, 2021 at 05.00 pm. During this period shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cutoff date (record date) of 05.11.2021 may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.
- 2. Shareholders who have already voted prior to the meeting date would not be entitled to vote at the meeting venue.
- 3. Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

- In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.
- 4. In terms of SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access e-Voting facility.

Pursuant to above said SEBI Circular, Login method for e-Voting and joining virtual meetings for Individual shareholders holding securities in Demat mode CDSL/NSDL is given below:

The Board of Directors have pleasure in presenting the 24th Annual Report of the Company along with Audited Balance Sheet as at 31st March 2021 and the Statement of Profit & Loss for the period ended 31st March 2021 together with the schedules and notes forming part of it, as audited and reported by the Auditors.

#### **Financial Results**

#### 1. Performance Review

The period under review has been the toughest and consequently challenging time for the Company, due to the pandemic Covid-19 and as the members are aware, the situation is yet to reach normalcy.

Thanks to the goodwill your Company enjoys in the market that even during this very difficult year, the performance has been almost at par with that of the previous year.

The Company has reported total turnover of Rs.13.78 Cr. for the financial year as compared to Rs.15.66 Cr. in the previous year. Profit before Tax and Profit after tax is Rs.01.20 Cr.and Rs.0.68 Cr. respectively as against Rs.01.30 Cr.and Rs.0.92 Cr. in the previous year. The revenue from operations of the company witnessed a decrease from Rs.15.65 Cr. in 2019-20 to Rs. 13.78 Cr. in 2020-21.

The economy measures implemented during the pandemic period has helped us to reduce the total expenses to Rs.12.59 Cr. which improved our bottom-line performance. The company has recorded a net profit of Rs. 0.68 Cr. during the financial year 2020-21.

#### 2. Dividend

To augment capital required for supporting and sustaining the growth of the Company, to retain the resources with the Company the Board of Directorshas not recommended any dividend for the Financial Year 2020-21.

#### 3. Reserves

During the FY 2020-21 the Company has utilized Rs.1,36,39,000/- from free reserves and Securities Premium Account to issue 13,63,900 fully paid Equity shares of Rs.10/- each as Bonus shares to the members.

During the period under report, the Company has reported a Net Profit of Rs 68,09,219/-and the Board proposes to transfer the same to the Reserves of the Company.

#### 4. Transfer of Unclaimed Dividend to Investor Education and Protection Fund:

The company has not declared dividend so far and hence the provision is not applicable.

#### 5. State of Company's Affairs:

Nature of Business and operations of the Company



During the year under review, there was no change in the nature of business of the Company. The company is mainly into the business of providing different types of retail loans to its customers such as Vehicle Loan, Loan Against Property, Pre-owned Car Loans, Personal Loans and Business Loans. The loan proposals are subject to strict due diligence under robust credit policies including credit check and field verification processes defined for each and every products on offer. The company continued to offer investment opportunities to customers in the form of fully secured Non-Convertible Redeemable Debentures strictly as per theReserve Bank of India guidelines.

#### **Economic Scenario**

Government of India & the Reserve Bank of India have been quite proactive in mitigating the difficulties of the financial sector, due to the ongoing Covid 19 Pandemic. The projected GDP growth in the current financial year points to recovery of the economy and this should augur well for the financial sector.

However, the expectations come with the caveat that the predicted third wave may not play havoc as during the 1<sup>st</sup> and 2<sup>nd</sup> waves. However, peoples have learned to live with the pandemic and the current market trends and indications are quite positive about the future and normalcy will return in social life and commercial activities soon.

#### **Business Plans**

As discussed in earlier para, even though your company is not an exception to overall market trend and common phenomenon of downward trend on growth prospects and liquidity crunch due to market slow down and Covid'19 pandemic outbreak we have been quite successful in keeping its impact indeed insignificant in our system. We have been able to honour all our financial commitments to statutory bodies, lenders and salaries to our employees during the moratorium period without any interruption.

The company has put in place fresh business plans for the current year, with equal emphasis on top line and bottom-line performances. We have started financing second hand two-wheelers where competition is weak in comparison to new vehicle loans. Simultaneously, we have started Institutional PL with focus on groups who may not have much exposure to the banking system. Institutional PL is getting acceptance in the market and there

are no competitors in the market. The company is also planning to introduce few more innovative products to tide over the present market situation and also to sustain momentum of growth even in this adverse phase.

#### **Branch Expansion**

As you are aware, during the previous financial year your company has taken a decision to hold on the branch expansion plan for the time being and to give more emphasis for consolidation of business in existing branches till market returns to normalcy. Our primary objective was to explore new areas using the existing branches. The directors are pleased to report that considerable progress has been achieved on this front.

Yours company has complied with all applicable regulations prescribed by Reserve Bank of India from time to time.

#### 7. Resource Mobilisation

The Company as an NBFC, mobilisation of resources at optimal cost and its deployment in the most profitable and secured manner constitutes the two important functions of the Company. The major source of funds of the company was credit lines from banks and financial institutions but now the company is giving more emphasis on retail fund mobilisation through allotment of Secured Redeemable Non-Convertible Debentures (NCDs).

#### **Share Capital**

The authorized share capital of the Company is `Rs.25 Cr. (2,50,00,000 Equity Shares of Rs. 10/each) and the paid-up share capital of the Company is 15.0029 Cr. (1,50,02,900 Equity Shares of Rs. 10/each).

During the financial year the company has issued 13,63,900 fully paid Equity shares of Rs.10/- each as Bonus shares to the existing members in the ratio of 1 (one) Equity Share for every 10 (ten) Equity Shares held.

#### **Issue of Non-Convertible Debentures**

To meet the business needs, Company has been issuing Secured, Redeemable and Non-Convertible debentures of varied interest rates



in due compliance to RBI guidelines and relevant sections of Companies Act, 2013 and an amount of Rs.8,05,05,000/- has been mobilized during the period under report. All the debentures are secured and charge is created in favour of Debenture Trustee to secure the interests of debenture holders. As on 31st March, 2021 the outstanding balance of Secured Non-Convertible Debentures is Rs.17.77 Cr as against Rs.10.44 Cr. in the previous year.

#### **Institutional Finance**

The Company was mainly depending on institutional finance for its working capital requirements since inception but now the institutional fund houses have stopped debt financing for the time being, in view of the volatile market, which has further aggravated matters. However, discussions are progressing with financial institutions and banks for credit facilities and it is expected to be closed positively soon.

As on March 31, 2021, the total outstanding amount of credit facilities from Banks were Rs.8.14 Cr. as against Rs. 13.68 Cr. as on March 31, 2020.

#### 8. Board Meetings

The Board of Directors has met 15 times to steer the affairs of the Company and the details are as given in **Annexure I**. The maximum interval between any two meetings did not exceed 120 days, as prescribed in the Companies Act, 2013.

#### **Resignation of Independent Director**

Mr. Rudran Puthukulangara (DIN: 00546638), Independent Director has resigned from the Board of directors with effect from 1<sup>st</sup> September, 2020 citing personal Reasons.

Mr. Ramanathan Annamalai (DIN: 02645247) was appointed as Independent Director in the Annual General Meeting held on 31<sup>st</sup> December, 2020 to fill vacancy caused due to the resignation of Mr. Rudran Puthukulangara.

#### **Resignation of Executive Director**

Mr. Puthamveetil Raman Sathyanarayanan (DIN: 07980702) has resigned from the post of Executive Director of the Company effective 1<sup>st</sup> October, 2020 due to his pre-occupation elsewhere and continuing as Non-Executive Director of the Company.

There has been no change in the Key Managerial Personnel of the Company during the financial year 2020-21

#### 1. Corporate information

TATTVA FINCORP LIMITED is registered with the Coimbatore Registrar of Companies as a Public Limited Company on 8th March, 1996 vide Registration no. U65921TZ1996PLC007015. The Company is holding a valid Certificate of Registration (COR) issued by Reserve Bank of India as a Non-Banking Financial Company without accepting public deposits vide certificate No. B-07-00612 dated 14th June, 2001.

The registered office of the company is located at F-1, First Floor, Balaji Castle No:11, Father Randy Street, R.S Puram Coimbatore TN 641002.

The Principal activities of the Company is to engage in providing various loans and advances like Business Loans, Vehicle Loans etc., The Operations of the Company is mostly concentrated within the State of Kerala and Tamil Nadu. The company has also opened a corporate office to manage the affairs of the company at Prasad Arcade, 2nd Floor, opp CMI Devamatha Provincial house, Patturaikkal, Thrissur -680 022

#### 2. Significant accounting policies

#### 2.1 Basis of accounting and preparation of financial statements

The financial statements of the Company have been prepared in accordance with the Generally Accepted Accounting Principles in India (Indian GAAP). The Company has prepared these financial statements to comply in all material respects with the Accounting Standards notified under the Companies (Accounts) Rules, 2014 (as amended) and the relevant provisions of the Companies Act, 2013. The financial statements are prepared and presented under the historical cost convention on the accrual basis of accounting and comply with the provisions of the Companies Act, 2013. The Company follows the directions prescribed by the Reserve Bank of India (RBI) for Non Banking-Financial Companies. Previous year figures are reclassified whereever required.

#### 2.2 Use of estimates

The preparation of the financial statements in conformity with Indian GAAP requires the Management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Although such estimates are made on a reasonable and prudent basis taking into account all available information, actual results could differ from those estimates.

#### 2.3 Cash and cash equivalents (for purposes of Cash Flow Statement)

Cash comprises cash on hand and demand deposits with banks. Cash equivalents are short-term balances (with an original maturity of three months or less from the date of acquisition), highly liquid investments that are readily convertible into known amounts of cash and which are subject to insignificant risk of changes in value.

#### 2.4 Cash flow statement

Cash flow Statement is prepared in accordance with the indirect method prescribed in Accounting Standard 3. The cash flows from operating, investing and financing activities of the company are segregated based on the available information.



#### 2.5 Property, Plant and Equipment

Property, Plant and Equipment are stated at cost net of depreciation. The cost of an asset comprises its purchase price and any cost directly attributable for bringing the assets to its working condition and location for its intended use. Depreciation has been provided on the straight-line method as per the rates prescribed in Part "C" of Schedule II to the Companies Act, 2013. Computer software is amortised over their expected useful life.

Depreciation on additions has been charged proportionately from the date of acquisition/installation. Individual assets costing less than Rs. 5000/- are depreciated in full, in the year of acquisition.

#### 2.6 Receivables Under Financing Activity

Receivables under Financing activities are classified into 'Performing and Non-Performing' assets in terms of the Non Banking Financial Companies Prudential Norms (Reserve Bank) Directions, 1998 issued by the Reserve Bank of India as amended from time to time.

#### 2.7 Revenue recognition

Revenues from Interest on loans financed by the company is recognized on accrual basis, considering the directions issued by the Reserve Bank of India from time to time in terms of the Non Banking Financial Companies Prudential Norms (Reserve Bank) Directions, 1998. Loans are classified into 'Performing and Non-Performing' assets in terms of the said Directions. Revenues from loan documentation and meeting charges are recognised as income on cash basis. Revenue from interest income on Fixed Deposits with Banks is recognized on time proportion basis taking into account the amount outstanding and the rate applicable. Processing fees at the rates as permitted by the RBI is charged on the loans disbursed and the same is recognised as and when collected at the time of loan disbursement.

#### **Income from services**

Revenues from contracts priced on a time and material basis are recognised when services are rendered and related costs are incurred. Revenues from turnkey contracts, which are generally time bound fixed price contracts, are recognised over the life of the contract using the proportionate completion method, with contract costs determining the degree of completion. Foreseeable losses on such contracts are recognised when probable.

Revenues from maintenance contracts are recognised pro-rata over the period of the loan.

#### 2.8 Employee benefits

Short term employee benefits including salaries, social security contributions, short term compensated absences (such as paid annual leave) where the absences are expected to occur within twelve months after the end of the period in which the employees render the related service, profit sharing and bonuses payable within twelve months after the end of the period in which the employees render the related services and non monetary benefits for current employees are estimated and measured on an undiscounted basis. Employee benefits include provident fund, superannuation fund, gratuity fund, compensated absences, long service awards and post-employment medical benefits.

#### 2.9 Segment reporting

The Company provides only Financial Services and does not have any other segment of business. So the Segmental reporting regulations are not applicable to the company.

#### 2.10 Earnings per share

Basic earnings per share is computed by dividing the profit / (loss) after tax (including the post tax effect of extraordinary items, if any) by the weighted average number of equity shares outstanding during the



year. Diluted earnings per share is computed by dividing the profit / (loss) after tax (including the post tax effect of extraordinary items, if any) as adjusted for dividend, interest and other charges to expense or income relating to the dilutive potential equity shares, by the weighted average number of equity shares considered for deriving basic earnings per share and the weighted average number of equity shares which could have been issued on the conversion of all dilutive potential equity shares. Potential equity shares are deemed to be dilutive only if their conversion to equity shares would decrease the net profit per share from continuing ordinary operations. Potential dilutive equity shares are deemed to be converted as at the beginning of the period, unless they have been issued at a later date. The dilutive potential equity shares are adjusted for the proceeds receivable had the shares been actually issued at fair value (i.e. average market value of the outstanding shares). Dilutive potential equity shares are determined independently for each period presented. The number of equity shares and potentially dilutive equity shares are adjusted for share splits / reverse share splits and bonus shares, as appropriate.

#### 2.11 Taxes on income

"Current tax is the amount of tax payable on the taxable income for the year after taking into consideration the benefits/disallowances admissible under the provisions of the Income Tax Act, 1961. Minimum Alternate Tax paid in accordance with the tax laws, which gives future economic benefits in the form of adjustment to future income tax liability, is considered as an asset if there is convincing evidence that the Company will pay normal income tax. Accordingly, MAT is recognised as an asset in the Balance Sheet when it is probable that future economic benefit associated with it will flow to the Company. Deferred tax is recognised on timing differences, being the differences between the taxable income and the accounting income that originate in one period and are capable of reversal in one or more subsequent periods. Deferred tax is measured using the tax rates and the tax laws enacted or substantially enacted as at the reporting date. Deferred tax liabilities are recognised for all timing differences. Deferred tax assets are recognised for timing differences of other items only to the extent that reasonable certainty exists that sufficient future taxable income will be available against which these can be realised. Deferred tax assets and liabilities are offset if such items relate to taxes on income levied by the same governing tax laws and the Company has a legally enforceable right for such set off. Deferred tax assets are reviewed at each Balance Sheet date for their realisability."

#### 2.12 Intangible assets

Intangible assets are carried at cost less accumulated amortisation and impairment losses, if any. The cost of an intangible asset comprises its purchase price, including any import duties and other taxes (other than those subsequently recoverable from the taxing authorities), and any directly attributable expenditure on making the asset ready for its intended use and net of any trade discounts and rebates. Subsequent expenditure on an intangible asset after its purchase / completion is recognised as an expense when incurred unless it is probable that such expenditure will enable the asset to generate future economic benefits in excess of its originally assessed standards of performance and such expenditure can be measured and attributed to the asset reliably, in which case such expenditure is added to the cost of the asset.

#### 2.13 Provisions and contingencies

A provision is recognised when the Company has a present obligation as a result of past events and it is probable that an outflow of resources will be required to settle the obligation in respect of which a reliable estimate can be made. Provisions (excluding retirement benefits) are not discounted to their present value and are determined based on the RBI Guidelines as at the Balance Sheet date. These are reviewed at each Balance Sheet date and adjusted to reflect the current best estimates. Contingent liabilities wherever applicable are disclosed in the Notes.
